- FY 2025 Proposed Executive Budget was presented
- Projected revenue increase of \$8.5 million
- Possible rate increase of \$4 per month on most products due to inflationary pressures and bonding needs
- May be able to free up cash from bond reserve accounts and not have to increase rates
- Last rate increase was over 10 years ago
- Projected operating expense increase of \$7.4 million
- UTOPIA distribution to cities increasing by the amount of city debt payments
